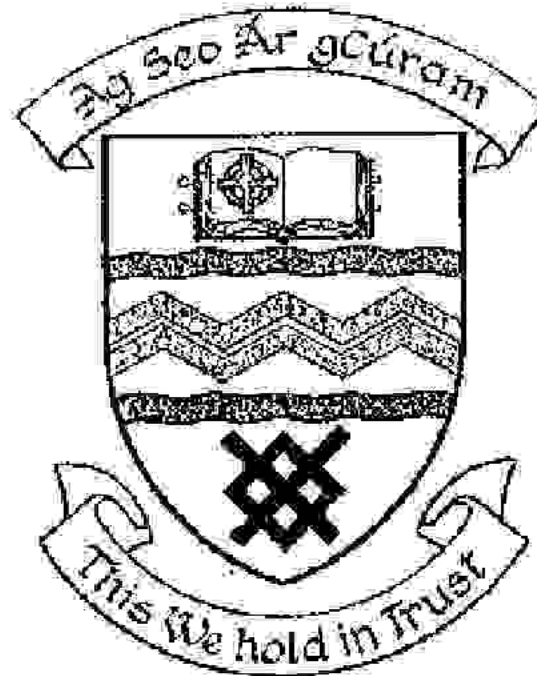

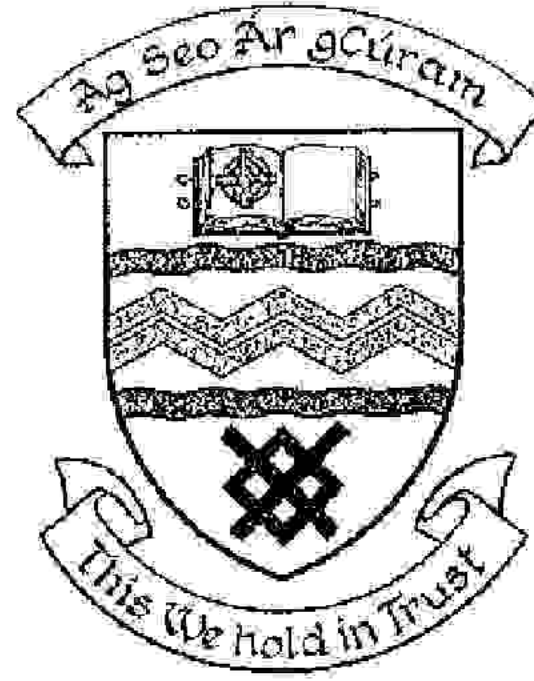

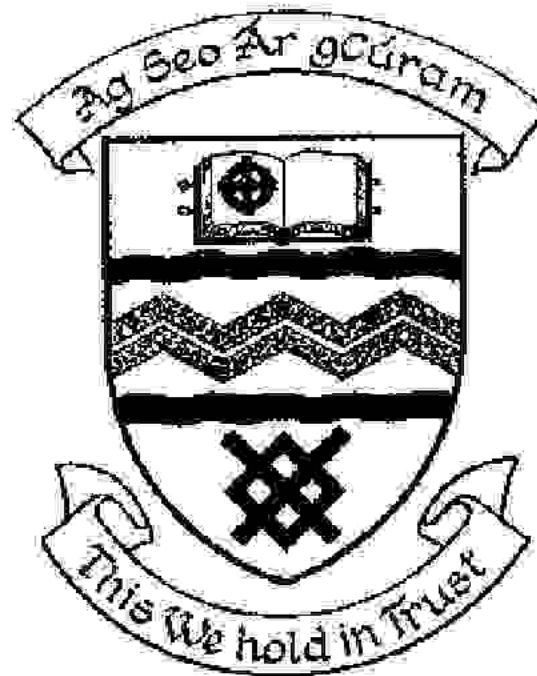

With reference to your planning application, received on 14/11/01 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1999 and the Planning and Development Act 2000, the following **ADDITIONAL INFORMATION** must be submitted in quadruplicate:

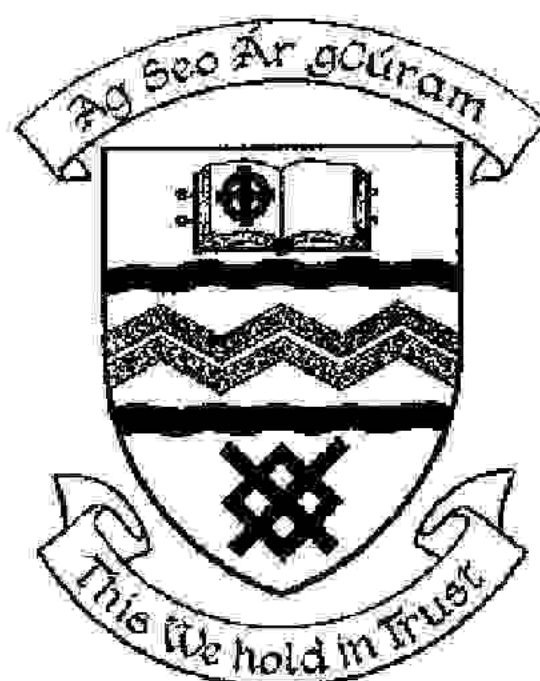
- 1 The applicant is asked to clarify the position with regard to the number of containers which are to be removed. A site layout map indicating the size and location of all containers on site shall be submitted. The applicant is requested to clarify precisely which containers are to be retained, if any, and which are to be removed.
- 2 Landscape details/site treatment details should be submitted showing proposals for the area which is presently used for the siting of the existing containers. In this regard the applicant is requested to furnish details on his compliance with Condition No. 3 of the permission granted by the Board in 1990 (PL 6/5/82218) relating to the landscaping of the site, and with Condition No. 1 of a decision granted by the Board in May 1995 (PL.06S.092928).
- 3 Information relating to the items that are to be stored in the new industrial unit should be submitted.
