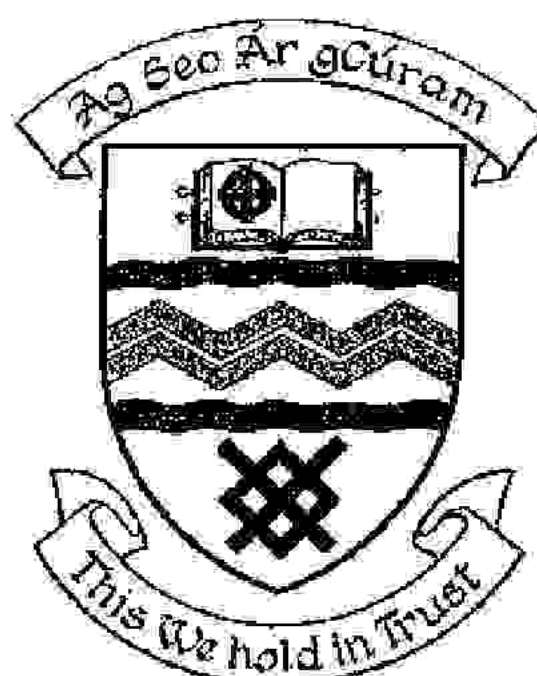

- 3 Please submit an elevation showing the existing dwelling in dotted line on the indicative elevations submitted namely, north elevation, east elevation and west elevation.

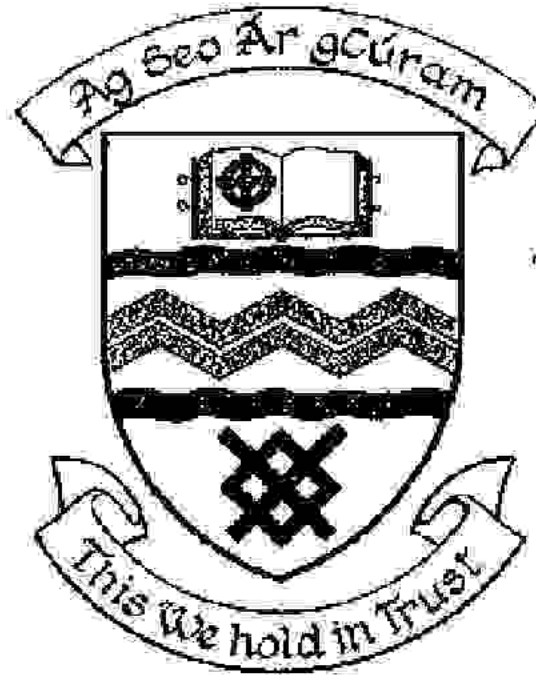

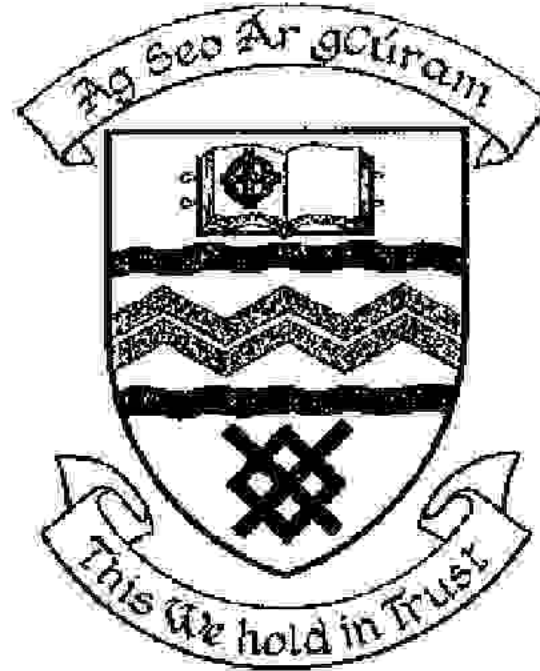
