REASONS FOR CONDITIONS

1. The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.
2. That before development commences, approval under the Building Bye-laws be obtained and all conditions of that approval be observed in the development.
3. That all relevant conditions of Order Nos. PA/194/82, (WA 2026) and PA/271/82 (WA 1367) be strictly adhered to in the development.
4. The developers shall pay a contribution of £25,000. to Dublin County Council for the construction of the final outfalls to the re-aligned Cammac River, this contribution to be paid forthwith.
5. Before any building work shall be put in hand on houses or industrial units, the applicants shall pay a contribution of £5,000. to Dublin County Council towards the re-alignment of the Cammac River.
