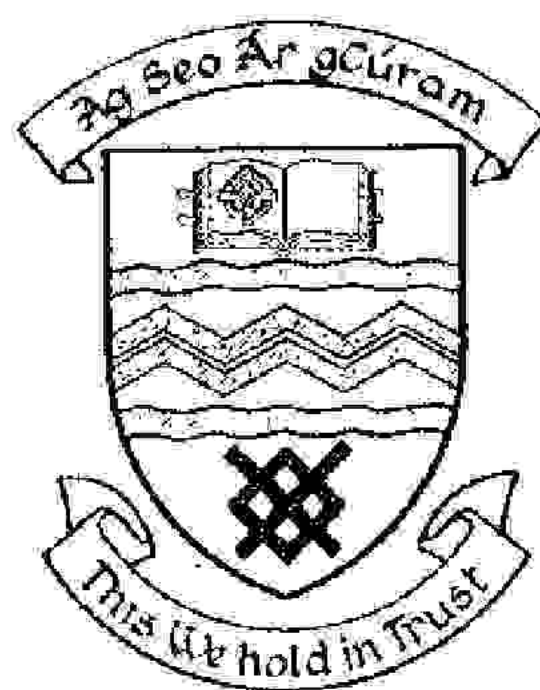

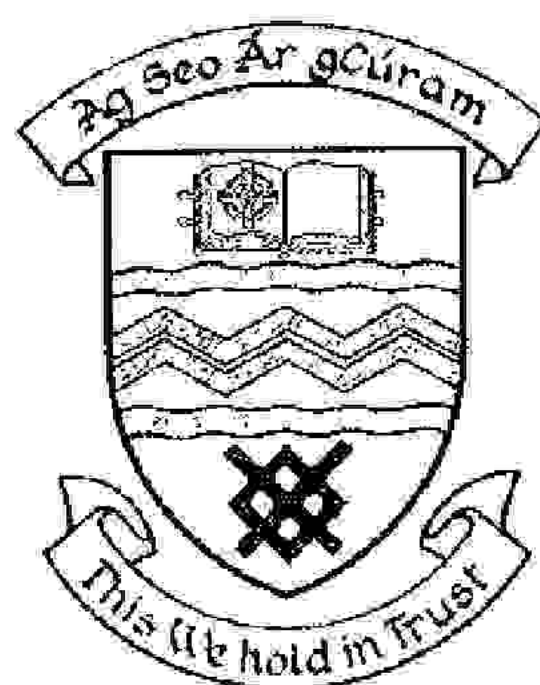

To ensure that the development shall be in accordance with the permission and that effective control be maintained.

- 2 That the pre-fabricated building shall be removed from the land when it is no longer required for use as a classroom and the land shall be restored to its former condition.

- 3 Prior to the commencement of the development, the applicant shall submit to the Planning Authority, drainage plans showing the exact location of all drains, gullies, manholes, AJs etc. located up to the point of connection to the public sewer. This layout shall be in accordance with the Building Regulations and shall show the full and complete separation of the foul and surface water systems. The applicant shall note that no building shall be erected within 5 metres of a public sewer or any sewer with the potential to be taken in charge. The applicant is advised to consult with the Environmental Services Department of South Dublin County Council in the above cases.

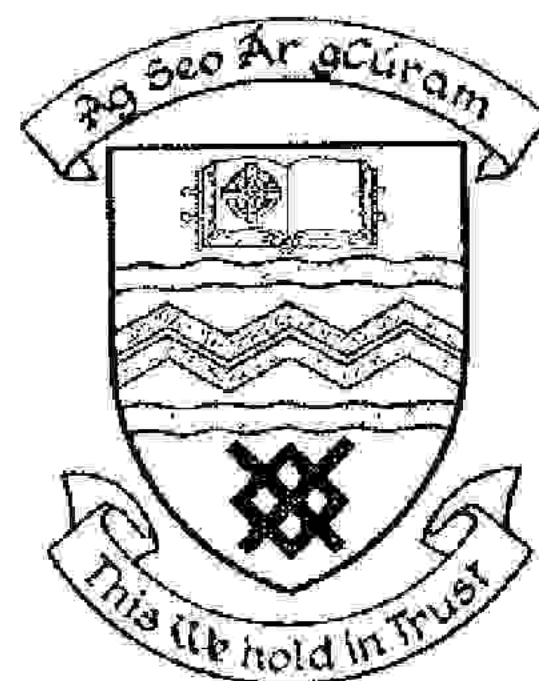

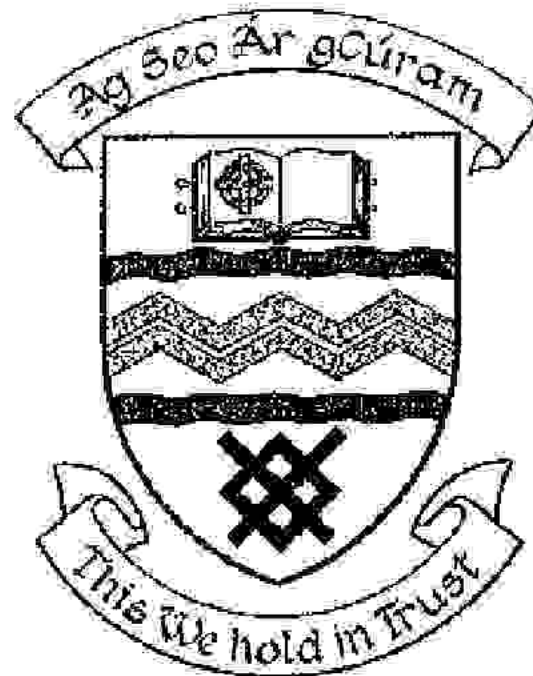

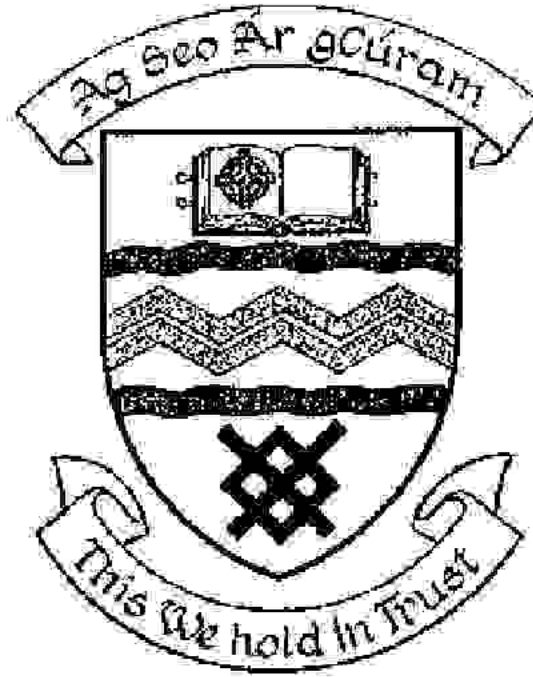
