

With reference to your planning application, received on 01/10/01 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1999 and the Planning and Development Act 2000, the following ADDITIONAL INFORMATION must be submitted in quadruplicate:

- The applicant is requested to submit a Site Layout Plan (scale not less than 1:500) to the Planning Authority clearly showing the extent of the proposed works, as per Section 23(1) of the Local Government (Planning and Development) Regulations, 1994. Detailed plans, elevations and sections are also required.
- The applicant should note that a site visit by the Roads
 Department showed that while it would be possible to provide
 3m x 90m vision splay on right hand side of site entrance
 (when exiting) without removing the existing front boundary
 hedging (facing affordable houses), it would not be possible
 to provide an adequate vision splay on left hand side of
 site entrance without removing the front boundary hedging.

Lorraine Dockery of the Planning Department (4149000 Ext. 2339) prior to responding to this request for additional information. Should the section of hedging on the left hand side (when exiting) require to be removed, the applicant is invited to consider submitting a replacement planting scheme consisting of native hedgerow species, in place of the wall required by Condition No. 15(6) of S99A/0771.

Condition 15(6) of Register Reference S99A/0771 states 'applicant to submit cross-section of buffer strip showing widened pathway (2.5m) along Boherboy Road frontage, boundary wall at back of this footpath, the remainder of the buffer strip and a kerb on the internal road'. The applicant is advised that no compliance has been received by the Planning Authority in respect of the above Condition. The applicant is requested to submit plans, elevations and sections showing insofar as is possible, compliance with the relevant parts of this condition together with details of this current proposal.
