

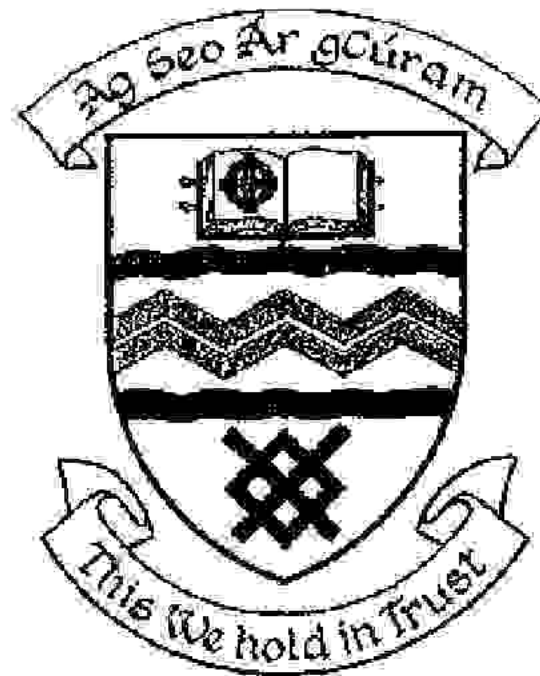

With reference to your planning application, received on 11/07/01 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1999 and the Planning and Development Act 2000, the following **ADDITIONAL INFORMATION** must be submitted in quadruplicate:

- 1 The applicant is requested to clarify the planning status of the other work shop unit to the rear of the site, the existing workshop to be demolished in the event that permission is granted under reg. ref. S01A/0212 and the office to the side of 104 Boot Road. Council records do not show that any permission exists in respect of these units. In the event that permission has been obtained the applicant shall submit the relevant reference number. In the event that planning permission has not been obtained the applicant shall submit revised public notices, elevations, layouts and the appropriate fee, so that all unauthorised development on the site is subject of the current application. This allows for a decision, which deals with the use of the site in a comprehensive manner.
- 2 The applicant shall submit details of how many staff are employed on the site.
