Reasons

- The proposal would constitute backland development which would conflict with the established pattern and character of development in the area and which would set an undesirable precedent for further similar development in the future. As such, the proposed development would be contrary to the proper planning and sustainable development of the area.
- It is considered that the development of a single house on this site would prejudice a more comprehensive redevelopment of the subject site and adjoining sites at higher densities. This would be desirable having regard to the location of the site close to a town centre and the availability of good public transport links. As such, the proposed development would be contrary to the proper planning and sustainable development of the area.
- The proposed house by reason of its two storey height and its close proximity to the houses of St. Maelruan's Park, would seriously injure the amenities of properties in the vicinity. As such, the proposal would also contravene materially the South Dublin County Development Plan zoning objective for the area, 'to protect and/or improve residential amenity'.
- The information submitted with the planning application is deficient in the following respects:
 - (i) Insufficient information has been provided regarding proposed water supply and drainage arrangements.
 - (ii) No details have been provided regarding the ownership of the lane which would be used to access the proposed house.
