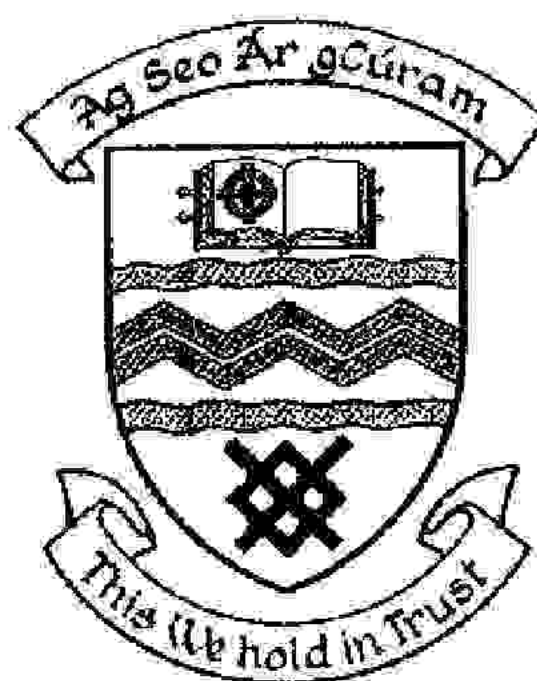

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.
REASON:
To ensure that the development shall be in accordance with the permission and that effective control be maintained.
 - 2 That all necessary measures be taken by the contractor to prevent the spillage or deposit of clay, rubble or other debris on adjoining roads during the course of the works.
REASON:
To protect the amenities of the area.
 - 3 Prior to the commencement of development the applicant shall submit samples of the proposed railings and brick to be used for the written agreement of the Planning Authority. The railings shall be bow top 20mm solid bar railing (powder coated and galvanised).
REASON:
In the interest of proper planning and development of the area.
 - 4 Entrance gate to be recessed 1.5 metres from the new boundary with wing walls splayed at 45 degrees.
REASON:
In the interest of proper planning and development of the area.
- (1) All buildings must be designed and constructed in accordance with the Building Regulations 1997.
 - (2) Building Control Regulations require a Commencement Notice. A copy of the Commencement Notice is attached.
 - (3) A Fire Safety Certificate must be obtained from the Building Control Authority, where applicable.
 - (4) Free Standing Walls must be designed and constructed in accordance with IS 325: Code of Practice for use of Masonry Part 1 : Structural use of unreinforced Masonry. The Owner must also ensure that the construction of all walls is supervised by a competent person.

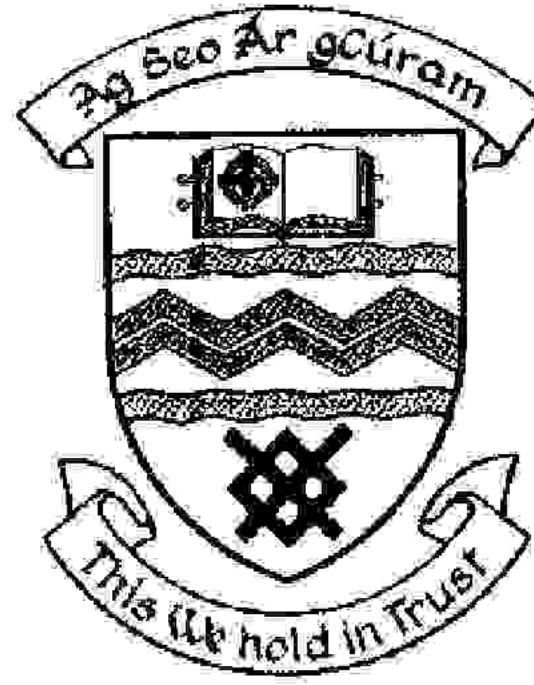

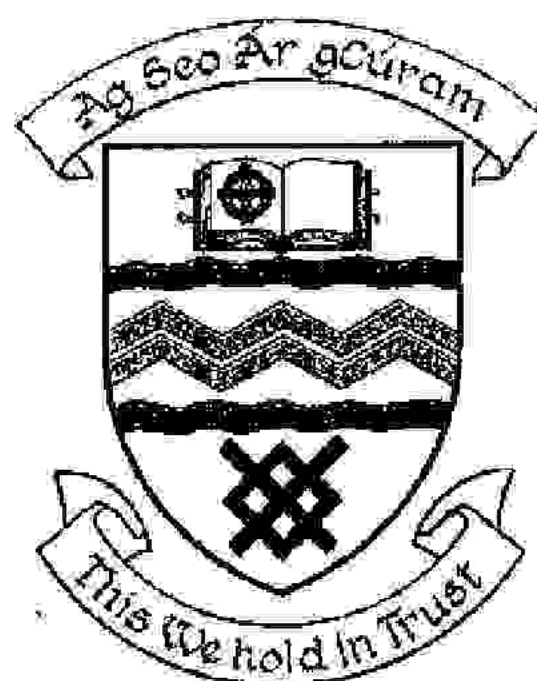

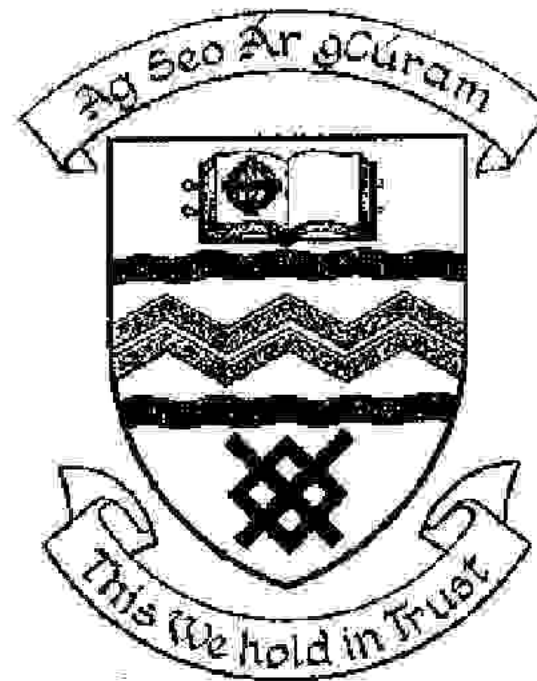
