Reasons

- The proposal would materially contravene the zoning objective as set out in the Development Plan, by failing to comply with residential development standards in areas designated as Green Belts in relation to site area, road frontage and site depth. The proposal would set an undesirable precedent for similar developments in the vicinity, which would lead to the erosion of the Green Belt and would, therefore, be contrary to the proper planning and development of the area.
- The roadway serving the proposed development, is substandard in width and inadequate to provide for the freeflow of traffic and the safety of pedestrians. It is considered that the proposed development, by the generation of additional traffic turning movements close to a sharp right-angled bend, on a substandard road, would endanger public safety by reason of traffic hazard.
