Reason: To ensure that the development shall be in accordance with the permission and that effective control is maintained.
 - 2 That the levels of illumination on all signs shall be adjusted at the applicant's expense if in the opinion of the County Council such adjustment is necessary.
Reason: In the interest of traffic safety.
- (1) All buildings must be designed and constructed in accordance with the Building Regulations 1997.
 - (2) Building Control Regulations require a Commencement Notice. A copy of the Commencement Notice is attached.

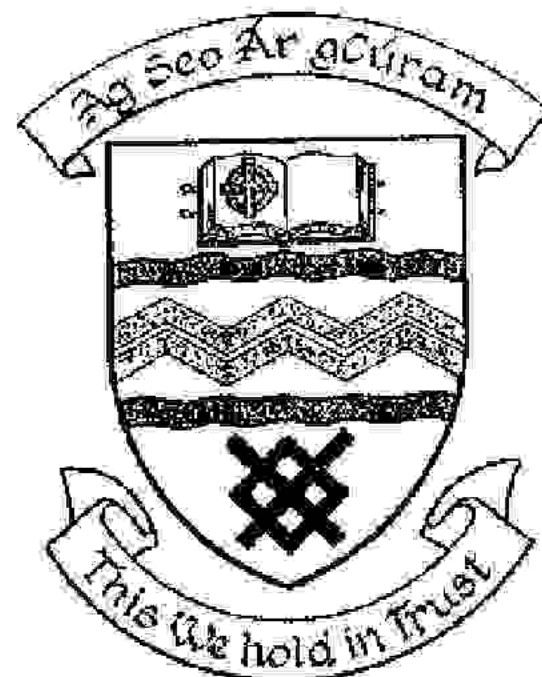

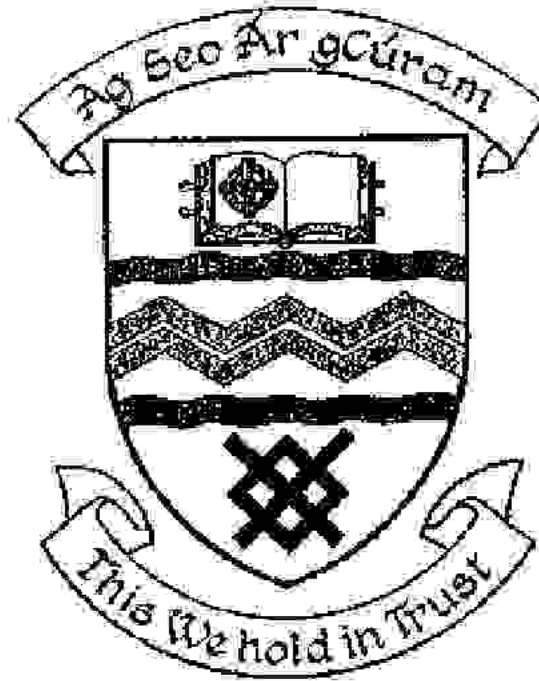
