BACK

CONDITIONS:-

(1) Subject to conditions 2, 3 and 4 the development to be carried out in strict conformity with the plans and specifications to which this permission relates. Approval under the building bye-laws to be obtained and all conditions of approval of construction and to prevent unauthorised development). (To achieve a satisfactory standard of construction and to prevent unauthorised development).

(2) The external walls of the proposed extension to be finished in a material to match existing walls.

(3) The fascia board of the proposed extension to be at the same level as the fascia board of the existing dwelling house.

(4) The window in the front wall of the proposed extension to be of the depth and constructed at the same level as the existing front windows of the dwelling house. (Conditions 2, 3 and 4 refer to visual amenity).

(5) The entire premises to be used only as a single dwelling unit. (To prevent unauthorised development).
