

## Reasons

- Having regard to the Development Plan requirements for private open space, public open space, and infill development, it is considered that the proposed development would constitute over-development of this restricted site, and would materially contravene development objectives of the 1998 South Dublin County Development Plan with regard to the provision of private open space in residential developments. The proposal does not therefore conform with the proper planning and development of the area.
- The proposed development involves building over a surface water sewer of 1050mm diameter, from which a five metre setback is normally required. The proposal would therefore be prejudicial to public health.
