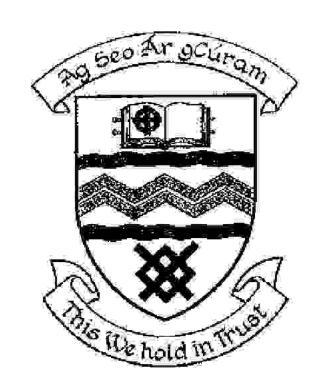

Reasons

- The proposed development would constitute undesirable, backland, substandard development that would result in disorderly development, the establishment of piecemeal development at the rear of the existing residential property, with insufficient parking provision. This would be out of character with existing properties in the area and would lead to a loss of residential amenity for properties in the area. It would therefore be contrary to the proper planning and development of the area.
- Because of the restricted dimensions, the shape of the site and the proximity of adjoining residences, the proposed development would set an undesirable density of development and present an overcrowded and disorderly appearance, and would seriously injure the amenities of the occupants of both the existing and proposed dwellings and also the amenities of other properties in the vicinity.
