Reasons

The retention of the uplighters, in combination with the existing downlighters above the sign, by reason of the level of illumination across a large area of the façade of the building in close proximity to the N4 National Primary Route, would be visually obtrusive and distract users of the public road and would, therefore, endanger public safety by reason of traffic hazard.

2 The uplighters, which are considered excessively large light fittings, are prominent features of the building façade. They are unsightly and conflict with the visual amenities of the area. The retention of the uplighters would therefore conflict with the proper planning and development of the area.

The applicant has not provided full details of the proposed light fittings. The proposal does not therefore conform with the proper planning and development of the area.
