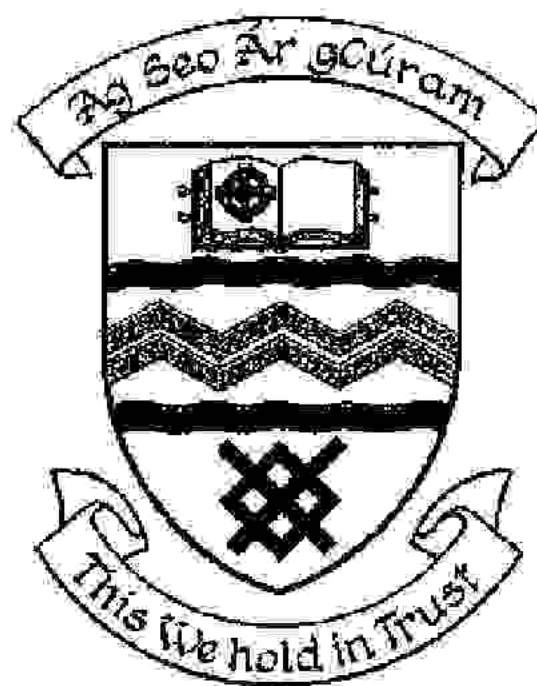

Dear Sir/Madam,

With reference to your planning application, received on 07/09/00 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following **ADDITIONAL INFORMATION** must be submitted in quadruplicate:

- 1 It is considered that the proposed extension of the car parking area to the south of the site would have unacceptable impacts on the residential amenity of the adjacent dwellinghouse. As such, the applicant is requested to submit revised proposals to relocate this proposed car parking area.
- 2 The applicant is requested to submit a detailed landscape plan to include a survey of existing trees and hedges indicating condition, species, spread, height and indicating those proposed to be retained and those proposed to be removed (if any); and to include full works specification and maintenance schedule including grading, topsoiling, seeding, drainage boundary treatment and planting. Particular attention should be paid to landscape proposals for areas of the site adjoining dwelling houses.
