## Reasons

- The normal Roads Department minimum setback of 2m between the side wall of a house and the back of the public pathway is not provided for. As such, the proposal would constitute sub-standard, disorderly development which would be contrary to the proper planning and development of the area.
- The proposed development would result in a gap between the nearest side walls of the existing and proposed houses which would fall considerably short of the 2.3m required by section 3.4.19 of the South Dublin County Development Plan, 1998.
- The proposed development on a restricted corner site would result in a cramped form of development which would be unduly visually prominent. As such, the proposed development would seriously injure the amenities of property in the vicinity.
