



With reference to your planning application, received on 08/08/00 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following **ADDITIONAL INFORMATION** must be submitted in quadruplicate:

- 1 The planning application did not include the drawings and plans of a sufficient standard required to be submitted with a planning application under Section 23, Part IV of the Local Government (Planning and Development) Regulations, 1994. This is not acceptable and does not allow for sufficient assessment of the proposal.
 - a) The applicant has not submitted any specifications relating to the sign. Detailed scaled drawings of the sign and proposed materials to be used shall be submitted.
 - b) The drawings submitted with the application do not indicate a scale. The applicant shall submit full drawings which are scaled.
 - c) The applicant shall submit detailed proposals for the lighting of the proposed sign.
