



**Conditions and Reasons**

- 1 The development to be carried out in its entirety in accordance with the plans, particulars and specifications lodged with the application, save as may be required by the other conditions attached hereto.  
REASON:  
To ensure that the development shall be in accordance with the permission and that effective control be maintained.
- 2 That the proposal shall conform with the terms and conditions of the permission granted under S99A/0233 save as may be amended by the other conditions attached hereto.  
REASON:  
In the interest of the proper planning and development of the area.
- 3 That the building granted by this permission shall be removed from the site to the satisfaction of the Planning Authority on or before June 15 2002 unless before that date permission for retention of the use is granted.  
REASON:  
In the interest of the proper planning and development of the area.

NOTE: The applicant's attention is drawn to Section 26(11) of the Local Government (Planning and Development) Act, 1963 which states, "a person shall not be entitled solely by reason of a permission or approval under this section to carry out any development".

NOTE: It is noted that a prefabricated structure was observed within the car park (in the vicinity of parking spaces numbers 1-7 on the submitted site plan). The applicant is advised that in the absence of planning permission this is an unauthorised development. The applicant is requested to regularise this situation.
