

Reasons

- The retention of the structures, which face Kennelsfort Road, would be visually obtrusive and would distract users of the public road and would, therefore, endanger public safety by reason of traffic hazard.
- The proposed retention of the structures, which are located in close proximity to residential developments, would injure the amenities of property in the vicinity and would be contrary to the proper planning and development of the area.
- The granting of permission for retention of the structures would contravene materially Policy H14 of the County Development Plan, which states: "it is the policy of the Council to restrict non-essential advertising structures, or any advertising structure which would impact injuriously on amenity, the built environment or road safety, and to have unauthorised signs removed". The proposal would therefore be contrary to the proper planning and development of the area.
