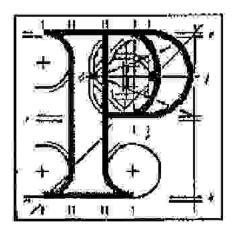

APPEAL by Gemma Dooley of 27 Templeroan Grove, Templeogue, Dublin against the decision made on the 7th day of September, 2000 by the Council of the County of South Dublin to refuse permission for development comprising the erection of a semidetached bungalow to side of number 2 The Drive, Kingswood, Belgard Road, Tallaght, Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1999, permission is hereby refused for the said development for the reason set out in the Schedule hereto.

SCHEDULE

The site of the proposed development is located on a corner site in a residential development where the zoning objective as set out in the current Development Plan for the area is "to protect and/or improve residential amenity", which objective is considered to be reasonable. It is considered that the proposed development, due to its size and location, would infringe existing building lines and would be out of character with existing developments in the vicinity. The proposed development would seriously injure the amenities of property in the vicinity and of the area and would, therefore, be contrary to the proper planning and development of the area.

Reasons

- The proposal to construct a semi-detached bungalow at this location would detract from the appearance of the area. The existing dwelling on the site is a detached bungalow, as are the properties adjoining the site both to the side and rear. As such the proposed development would seriously injure the amenities of property in the vicinity.
- The proposed development would be out of character with existing development in the area due to its design and orientation. Given the prominent location of the proposed development on a corner site, the proposed development would be visually obtrusive and by virtue of the precedent it would set, it would seriously injure the amenities of property in the vicinity.
