

APPEAL by Anne O'Dea care of Catherine Fitzgerald, Architect of 278 Merrion Road, Merrion Gates, Dublin against the decision made on the 2nd day of October, 2000 by the Council of the County of South Dublin to refuse permission for development comprising the construction of a three bedroom dwelling adjacent to 25 Coolamber Court, Knocklyon, Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1999, permission is hereby refused for the said development for the reasons set out in the Schedule hereto.

SCHEDULE

- 1. It is considered that the form and design of the proposed three-storey house would not integrate with and would be out of character with the style of adjoining development. The proposed development would contravene the provisions of the current South Dublin County Development Plan regarding corner/side garden sites, would be visually incongruous, and would, therefore, seriously injure the visual amenities of the area and be contrary to the proper planning and development of the area.
- 2. The proposed development, by reason of its south facing third-storey bedroom window, would result in serious overlooking and loss of privacy of the dwelling located south of the site and would, therefore, seriously injure the residential amenities of this property. The proposed development would, therefore, be contrary to the proper planning and development of the area.


