

Reasons

- Having regard to the location of the proposed development in an area zoned 'B' in the current South Dublin County Development Plan for which the objective is "to protect and improve rural amenity and to provide for the development of agriculture" and the present number of dwellings in the vicinity already, it is considered that the proposed development would materially contravene this objective.
- The generation of additional traffic/turning movements on a heavily trafficked substandard regional route would endanger public safety by reason of traffic hazard.
- The proposal constitutes undesirable ribbon development on a substandard rural road network, which will lead to a demand for the uneconomic provision of services and would set an undesirable precedent for further similar developments in the area.
- Insufficient information has been supplied with respect to foul and surface water drainage. In particular, details of proposed drainage up to and including connection to the septic tank and method of disposal of surface water have not been provided, and percolation tests have not been carried out to prove that the surrounding wells are not too close. As such the proposed development must be considered to be prejudicial to public health.
