

With reference to your planning application, received on 16/06/00 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following ADDITIONAL INFORMATION must be submitted in quadruplicate:

- The applicant's proposal, which appears to indicate that all foul effluent including effluent from 2 no. wash bays and all domestic effluent will discharge to an unidentified location on Knockmitten Lane via a petrol interceptor and silt trap, is unacceptable. Applicant to submit full details of proposed foul drainage, including pipe sizes, gradients, cover and invert levels, up to and including connection to public sewer. Details of silt traps and interceptors, including sizes and basis for selection, i.e. design calculations, to be submitted. Domestic effluent is not to discharge to foul sewer via a silt trap and petrol interceptor.
- Applicant to submit full details of proposed surface water drainage, including pipe sizes, gradients, cover and invert levels, up to and including connection to public sewer.

Details of silt trap/s and interceptor/s, including sizes and basis for selection, i.e. design calculations, to be submitted.

- The applicant is advised that all surface water runoff from truck parking, marshalling and any other areas where there is a possibility of spillages or contamination shall be routed via an adequate petrol/oil/diesel interceptor and silt trap arrangement before discharging to the public sewer.
- The applicant has submitted inadequate details on water.

 Applicant to submit a revised watermain layout drawing.

 Drawing to indicate proposed watermain sizes, valve, meter and hydrant layout, proposed points of connections to existing watermains.
- It is noted that planning permission was granted to the applicant for a change of use from warehouse to recycling centre and external improvements on a site fronting this substandard laneway. It is noted that Condition No. 3 and 7 of An Bord Pleanala's decision Ref. No. PL.06S.112004 have not been complied with. The applicant shall submit a timescale/phasing programme for completion of Condition No's. 3 and 7 of An Bord Pleanala's decision Ref. No. PL.06S.112004.
- The applicant shall submit a site layout plan to a scale of 1/500.
- The applicant shall submit a site location map and highlight in colour any sites in the vicinity which are in the applicants ownership. It is noted that there is another site fronting the site in the applicant's ownership which is being used as a recycling centre. The applicant is requested to confirm whether any changes are intended to be made in the implementation of the existing permission under Reg. Ref. S99A/0063 as a result of the implementation of the proposed development the subject of this application. Any such changes shall be fully detailed and included as part of the present application in accordance with relevant statutory requirements.
