Reasons

- It is considered that the proposed development is not consistent with Policy RH1 and would result in the further erosion of rural amenity in the area and would therefore contravene materially a development objective indicated in the South Dublin County Development Plan, 1998, for the use solely or primarily of particular areas for particular purposes i.e. zoning objective 'B' "To protect and improve rural amenity and to provide for the development of agriculture". - The proposed development would constitute undesirable ribbon development on a substandard rural road network which would be likely to lead to uneconomic demands for the provision of services and would set an undesirable precedent for further similar development in the area.
