

APPEAL by Nitelites Ireland Limited of Beech House, Beech Hill Road, Dublin against the decision made on the 8<sup>th</sup> day of September, 2000 by the Council of the County of South Dublin to refuse permission for development comprising the retention of advertising sign measuring 20 foot by 10 foot in the Mill Centre Car Park at the rear of 8 Leinster Terrace, Clondalkin, Dublin:

**DECISION:** Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1999, permission is hereby refused for the said development for the reasons set out in the Schedule hereto.

#### SCHEDULE

- 1. Having regard to the policies of the planning authority as set out in the current Development Plan for the area with regard to restricting non-essential structures, the relationship of signage to the development to which it is attached, the scale of signage in areas frequented by pedestrians and the design of signage in village improvement areas, it is considered that the development proposed to be retained would be contrary to these policies and would, therefore, be contrary to the proper planning and development of the area.
- 2. Having regard to the location and scale of the sign for which retention is proposed, it is considered that the development proposed to be retained would seriously injure the visual amenity of the area and would, therefore, be contrary to the proper planning and development of the area.
