Reasons

- Having regard to the inadequate separation from public services in the adjacent footpath, the inadequate setback from the gable end of the proposed house and the back of the public pathway, and the shortfall in private open space, it is considered that the proposed development does not comply with Development Plan standards and would constitute over development on a restricted site.
