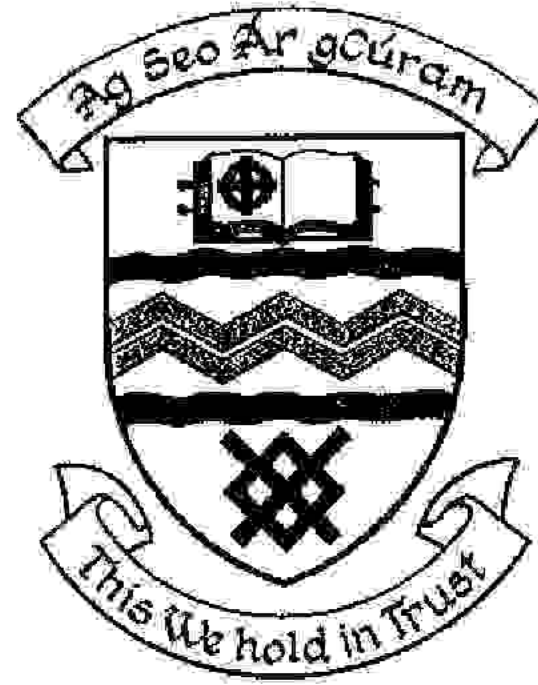

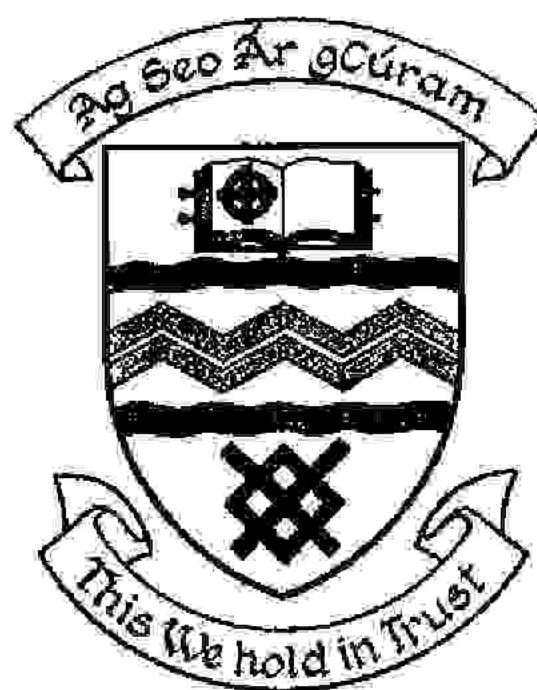

**Reasons**
