

APPEAL by Francis Harrington care of Gráinne Mallon and Associates of 6 Merrion Square, Dublin against the decision made on the 12th day of September, 2000 by the Council of the County of South Dublin to refuse permission for development comprising the retention and completion of dwelling and use of existing access from Cruagh Road at Killakee, Rathfarnham, County Dublin:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1999, permission is hereby refused for the said development for the reasons set out in the Schedule hereto.

SCHEDULE

1. The proposed development would contravene materially a condition attached to an existing permission for development namely, condition number 4 attached to the permission granted by An Bord Pleanála on the 11th day of August, 1992 under appeal reference number PL 6/5/88128 and would not be acceptable in terms of traffic safety and convenience or in the interest of orderly development. The proposed development would, therefore, be contrary to the proper planning and development of the area.

2. It is considered that the existing right-of-way over a long narrow poorly surfaced agricultural track with substandard sightlines at its junction with the public road is not an appropriate or safe access. The proposed development would result in a traffic hazard and would be contrary to the proper planning and development of the area.


