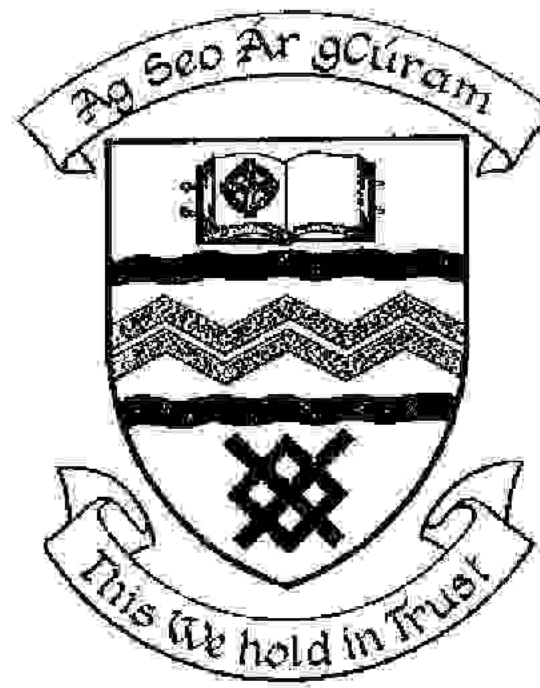

Reasons

- 1 The proposed development, by reason of its scale, height, appearance and proximity to surrounding residential development would seriously injure the amenities and depreciate the value of property in the vicinity.
