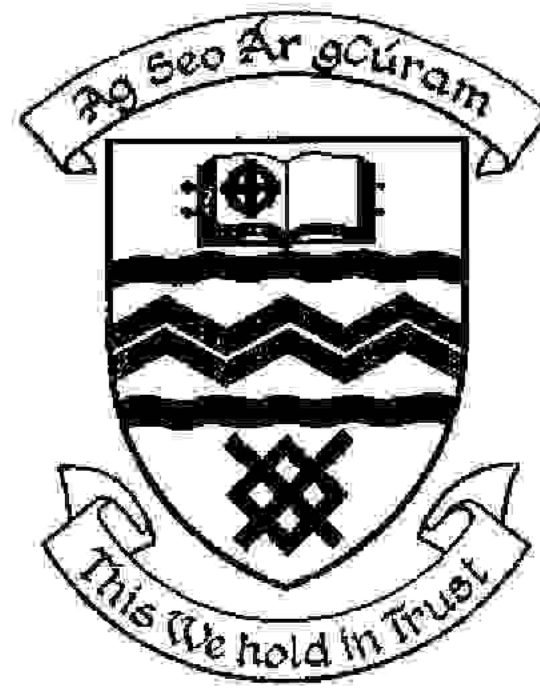

**Reasons**

- 1 It is policy that for safety reasons, no development which penetrates the transitional surface of Weston Aerodrome, be permitted within the Restricted Area on land which comprises the Aerodrome and lands immediately adjoining it. As the hanger proposed for retention does penetrate the transitional surface, the proposed development conflicts with public safety.
- 2 The proposed development is within the Restricted Area of Weston Aerodrome and would endanger or interfere with the safety of aircraft.
