

The proposed development would, therefore, be contrary to the proper planning and development of the area.
- 2. It is considered that the proposed alteration of the roof profile and the use of roof windows in the front elevation, would be out of character with the existing development, would be visually obtrusive and would, therefore, be contrary to, the proper planing and development of the Clondalkin Conservation Area.
