

Reasons

- The proposed development will result in demand for additional car parking. The failure to provide additional off street parking would endanger public safety by reason of traffic hazard.
- In view of the general inability to provide additional off street car parking spaces, a grant of planning permission would constitute an undesirable precedent for further similar proposals within this retail park.
