

Reasons

- The applicant does not appear to have any right of vehicular access or to park within the vicinity of the site. The proposed development would be likely to result in hazardous on-street public parking along a narrow road. In the absence of satisfactory off-street parking arrangements, the development would therefore endanger public safety by traffic hazard.
- Notwithstanding the fact that the applicant does not appear to have access rights along the roadway, the proposed development would be likely to result in additional traffic turning movements at the junction between the access road and the Hazelhatch Road, at a point where visibility is very poor. The proposed development would therefore endanger public safety by reason of traffic hazard.
- The proposed structure is inappropriate for this visually sensitive rural location along the canal, and in close proximity to a number of residential properties. Accordingly, it is considered that the proposal is injurious to the rural and residential amenities of the area.
