



Reasons

- The proposed development does not meet the requirements of Section 3.4.19.i of the 1998 South Dublin County Development plan which requires a minimum of 2.3 metres separation between the flank walls of each house.
- The subject site is zoned 'A', "to protect and/or improve residential amenity" in the South Dublin County Development Plan 1998. It is considered that the proposed development and its associated features would materially contravene the said zoning objective and would be contrary to the proper planning and development of the area.
- The proposed development is within the required wayleave of metres from a 750mm diameter surface water sewer: Therefore the proposed development would be contrary to public health.
