## Reasons

- The proposed development by virtue of its design and size, would be visually at variance with the established pattern of development in this area. The proposed development would be out of character with existing development and would therefore be injurious to the visual amenities and would seriously injure the amenities and depreciate the value of property in the vicinity.
