Reasons

The proposed signage by virtue of the amount proposed and by virtue of its size, location and superfluous nature would set a precedent for further such development within The Square Shopping Centre complex and would contravene materially the objective of the South Dublin County Development Plan 1998 which is to restrict non-essential advertising structures, or any advertising structure which would impact injuriously on amenity or the built environment.
