
Reasons

- The proposed location of the dwelling would be in breach of Section 3.4.19 of the Development Plan with regard to providing a minimum separation of 2.3 metres between the flank walls of adjoining dwellings. The current proposal allows for a separation of 0.850 metres which is unsatisfactory. The proposal would therefore be injurious to the residential amenities of both dwellings and preclude against an adequate level of maintenance for each house on site. As such the proposed development would seriously injure the amenities of property in the vicinity.
- The setback between the gable end of the proposed single storey side extension and the back of the public footpath is below the 2 metres required by the Roads Department. This is unsatisfactory and contrary to the proper planning and development of the area.
- It is noted that proposed relocation of the dwelling would result in the dwelling being within 3 metres of a 225m surface water sewer. The proposal would therefore be prejudicial to public health.
