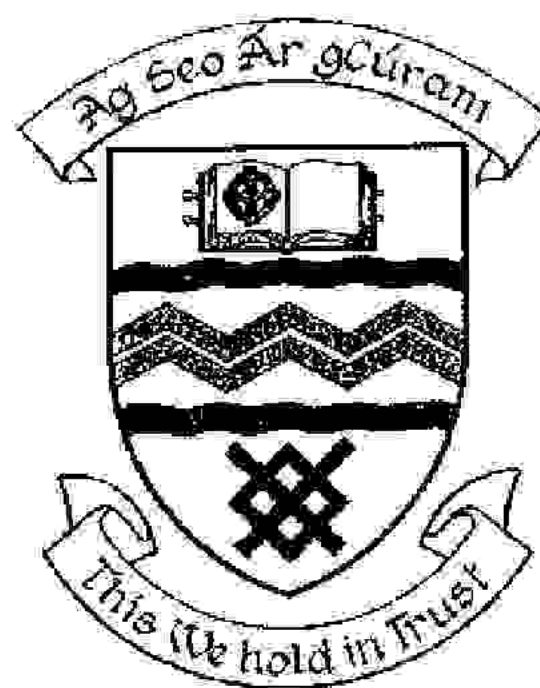

**Reasons**

- 1 It is considered that the proposal in this application to retain the creche and montessori on the subject site materially contravenes Development Plan policy regarding childcare provision in residential areas as stated in Section 2.2.8.

Section 2.2.8.i of the Development Plan states that home based economic activities include "childcare provision, such as creche, nursery school, playschool etc." It also states that:- "Home based economic activities are small scale commercial and professional activities carried out by residents of the dwelling, and are subordinate to the main use of the property as residential accommodation".

Section 2.2.8.ii lists the circumstances under which planning permission for such uses may be granted. These include: "permission for home based economic activity will only be granted to the resident of the house".

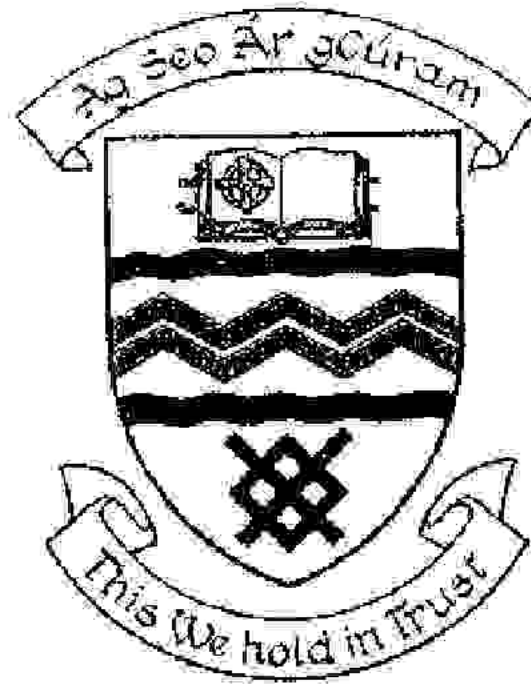
These Development Plan requirements are not adhered to in this application.

- 2 It is considered that this proposal is seriously injurious to the amenities of property in the vicinity for reasons including increased noise.
