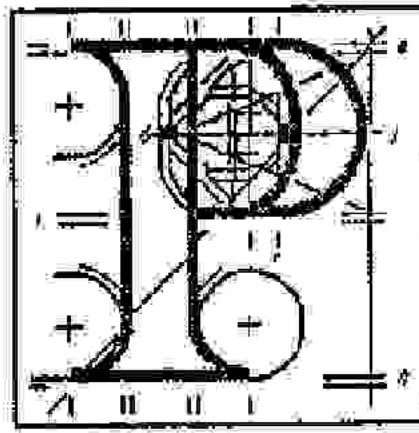

APPEAL by Eamonn Grumley care of Vincent Traynor of 3 Castlebrook, Dundrum, Dublin against the decision made on the 11th day of May, 2000 by the Council of the County of South Dublin to grant subject to conditions a permission for development comprising retention of the continuance of the use of part of the storage area as a wholesale showroom and the retention of signage at the entrance walls, a free standing sign and signage on the building at Lucretia Tiles, Adamstown, Newcastle Road, Lucan, County Dublin in accordance with plans and particulars lodged with the said Council:

WHEREAS the said appeal relates only to conditions numbers 2, 5, 6, 7, 12 and 13 subject to which the decision was made:

AND WHEREAS the Board is satisfied, having regard to the nature of the said conditions, that the determination by the Board of the relevant application as if it had been made to it in the first instance would not be warranted:

NOW THEREFORE An Bord Pleanála, in exercise of the powers conferred on it by subsection (1) of section 15 of the Local Government (Planning and Development) Act, 1992, hereby directs the said Council to remove the said conditions numbers 2, 5, 6, 12 and 13 and the reasons therefor and to attach condition number 7 and the reason therefor.
