



With reference to your planning application, received on 25/02/00 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following ADDITIONAL INFORMATION must be submitted in quadruplicate:

- The applicant shall clarify the room(s) of the dwelling which are used for the purposes of the creche. On inspection, it was noted that an extended kitchen area to the rear is in use for the purposes of the creche. A revised up to date floor plan is required which clearly indicates the room(s) in use.
 - (b) The applicant shall clarify if any upper floor rooms are in use for the purposes of the crecke.
