Reasons

- The site of the proposed development is in an area zoned "to protect and enhance the outstanding natural character of the Dublin Mountain Area" in the South Dublin County Development Plan 1998. The applicant has not demonstrated that she can meet the requirements for housing in this zoning as set out in the Development Plan. On the basis of the submitted details the proposed development would contravene materially the zoning objective indicated in the Development Plan "to protect and enhance the outstanding natural character of the Dublin Mountain Area" and would therefore be contrary to the proper planning and development of the area.
- Visibility at the junction of Lugg Lane and Slade Road is severely sub-standard. The generation of additional traffic turning movements at this location would endanger public safety by reason of a traffic hazard.
- 3 The construction of a dwelling on this elevated site would be visually obtrusive at this location and would be contrary to the proper planning and development of the area and the zoning objective for the area in the Development Plan. The proposed design does not accord with the Guidelines on the Siting and Design of Rural Dwellings in Appendix D of the South Dublin County Development Plan 1998.
