

APPEAL by The Echo of Echo House, Old Bawn Road, Tallaght, Dublin against the decision made on the 13<sup>th</sup> day of October, 2000 by the Council of the County of South Dublin to refuse permission for development comprising the retention of change of use of number 50 Old Bawn Road to offices and internal door linking number 48 and number 50 Old Bawn Road, the retention of front cobblelock apron for car parking, all at 48 and 50 Old Bawn Road, Tallaght, Dublin:

**DECISION:** Pursuant to the Local Government (Planning and Development) Acts, 1963 to 1999, permission is hereby refused for the said development for the reason set out in the Schedule hereto.

#### SCHEDULE

The development proposed to be retained is located in an area zoned in the current South County Dublin Development Plan "to protect and improve residential amenities", which zoning is considered reasonable. It is considered that the development proposed to be retained seriously injures the residential amenity and value of property in the vicinity. The development proposed to be retained therefore, contravenes materially the Development Plan and is contrary to the proper planning and development of the area.


