

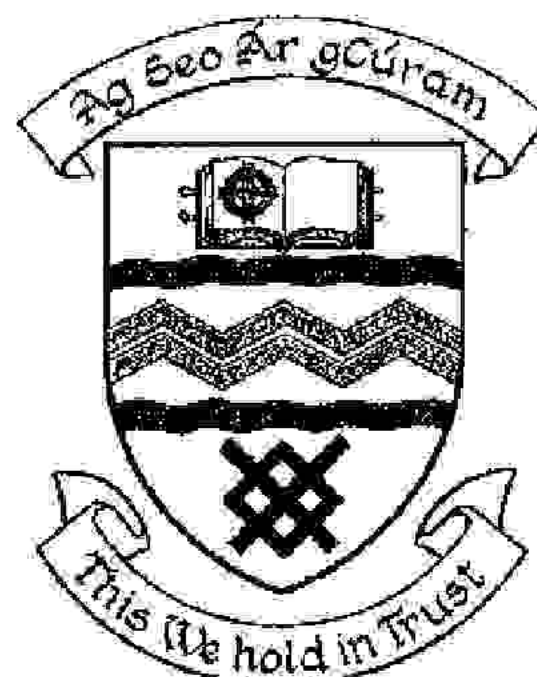

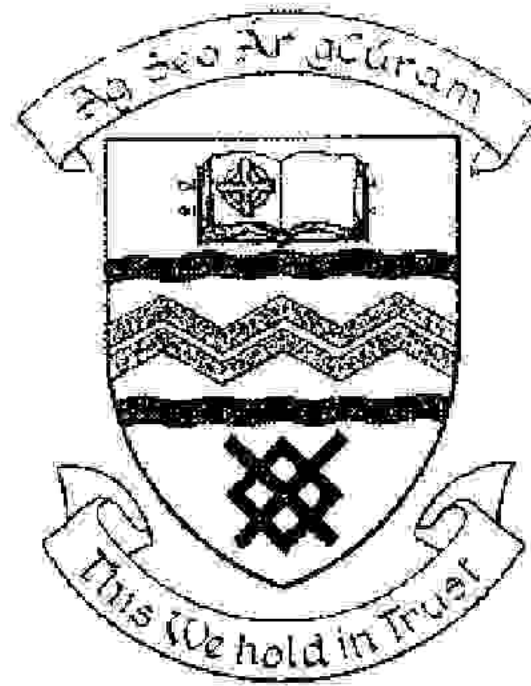

With reference to your planning application, received on 03/02/00 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following ADDITIONAL INFORMATION must be submitted in quadruplicate:

- 1 The applicant is requested to submit a map showing all land within his ownership, and all land which is in use in connection with the caravan business at Tay Lane. The precise use of each part of the lands and each structure to be stated.
- 2 The applicant shall submit a car parking layout and indicate how the car parking standards of the County Development Plan may be satisfied.
- 3 The applicant is requested to submit details of the proposed roof finish.
- 4 The applicant is requested to submit any proposals he may have for an alternative layout which will not involve breaking the established front building line along Tay Lane.
- 5 The applicant is requested to submit full details of the proposed fascia signage.

- 6 The applicant is requested to submit any proposals he may have for amending the proposed roof design to a more traditional "A" type roof.
- 7 The applicant is requested to submit any proposals he may have, and if it is within his control, to improve the vision splays at the junction of Tay Lane/Commons Road. In this regard, Roads Department indicate that the vision splays could be improved by the removal of some hedge.
- 8 The applicant is requested to submit a revised site layout plan detailing landscaping and boundary treatment for the entire site which would serve to fully and appropriately integrate the proposal into this rural area.
