

With reference to your planning application, received on 19/01/00 in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning & Development) Acts 1963-1993, the following ADDITIONAL INFORMATION must be submitted in quadruplicate:

- 1 The applicant is requested to submit any proposals he may have to redesign the proposed development so that it is more sympathetic to its sensitive location in relation to the Liffey Valley Special Amenity Area, which abuts the site. Any revised drawings shall include detailed longitudinal sections through the building and the adjoining units.
- 2 The applicant is requested to indicate car parking proposals for the proposed development. A layout showing the location of the additional spaces arising from the proposed development is required.

NOTE: The applicant is advised to contact the Planning Department prior to responding to this request for additional information.


