Reasons

The access to the proposed house would be on the boundary fronting the end of the cul-de-sac on Templeroan Green. The proposed development would contravene materially a condition attached to a previous permission for development namely, condition number 2 attached to the permission granted by An Bord Pleanala on the 13/09/90, under appeal reference number PL 6/5/81816 for the retention of a house on a reduced site at 38 Templeroan Grove, which condition specified, inter alia, that "no access shall be taken through the boundary fronting the end of the cul-de sac".
