

Reasons

- The proposed development would result in excessive overshadowing of the adjoining dwelling site to the west. It would therefore be seriously injurious to residential amenity and would devalue the adjoining property.
- The proposed development would result in an additional dwelling unit located in close proximity to an existing stand of trees, which are of significant amenity value. Development of the proposed house would detract from the setting of the trees and result in deterioration in the overall quality of the development. The proposed development does not therefore conform with the proper planning and development of the area.
- The proposed development, by developing onto an area indicated as use for open space, would materially contravene Condition No. 1, which is attached to an existing permission for development, Reg. Ref. S99A/0019.
