With reference to your planning application received here on 29th May, 1978, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976, the following additional information must be submitted in quadruplicate:-

1. It is the opinion of the Roads Engineer that it would be difficult to provide adequate vision splays at the vehicular access because of the curve on the road and the high stone wall. Information is required as to the proposed sight lines which would be available at the proposed new access.
2. Clarification is required as to whether or not it is intended that the proposed 24-ft. carriageway would become a public road or remain in private ownership.

NOTE: It is suggested that the applicant consult with the Planning Authority prior to the submission of Additional Information.
