With reference to your planning application received here on 13th March, 1978, in connection with the above, I wish to inform you that before the application can be considered under the Local Government (Planning and Development) Acts, 1963 and 1976, the following additional information must be submitted in quadruplicate:-

1. Specific evidence of soil suitability for the disposal of septic tank effluent together with the necessary percolation areas, potability of proposed water supply together with all necessary trial holes and percolation tests acceptable to the Health Inspector's Department are required.
2. Specific evidence of the applicant's need for an additional dwellinghouse.
