APPEAL by Patrick O'Shea of 29 Ardmore Crescent, Artane, Dublin, against the decision made on the 13th day of April, 1978, by the Council of the County of Dublin deciding to refuse to grant an outline permission for the erection of a bungalow on a site at Ballinascorney Upper, Brittas:

DECISION: Pursuant to the Local Government (Planning and Development) Acts, 1963 and 1976, outline permission is hereby refused for the erection of the said bungalow for the reason set out in the Schedule hereto.

SCHEDULE

The site is in the Dublin Mountain zone in an area designated in the county development plan as one of high scenic amenity. It is the policy of the planning authority that any development in this area not directly related to its amenity potential or its use for agriculture, mountain or hill farming should be prohibited. This policy is considered reasonable and the proposed development would be in conflict with it and seriously injurious to the visual amenities of the area.
