ORDER: In accordance with the recommendation of the Assistant Principal Officer, I decide that having regard to the provisions which are included in the Development Plan, the above proposal would be consistent with proper planning and development and I, therefore, decide **TO GRANT** **PERMISSION** therefor under the Local Government (Planning and Development) Act, 1963 subject to the following **5** conditions imposed for the reasons stated;

Conditions

Reasons for Conditions

1. The development to be carried out, in conformity with G.I.E. Drawing Nos. 129/9 dated 24.7.78 and GS72/1 and the specification lodged with the application, save as may be required by the other conditions attached hereto.

2. The applicants shall make satisfactory arrangements for the maintenance, repair and upkeep of the structure.

3. The applicants shall accept responsibility for the removal of the structure at their own expense, if such is necessary, for the purposes of road widening, reconstruction or repair and for the repair, replacement and renewal of any service installed in the public street.

4. The lighting of the panels to be carried out so as not to cause excessive glare or distraction to road users or adjoining property owners and the hours of lighting shall not extend beyond the hours of lighting of the adjoining street lights.

5. The shelter shall be relocated in a south easterly direction so that its south eastern panel is located approximately 2.5ft. from the public lamp standard situated near the boundary between No. 34 & 35 Grange Rd.
